- Application will be required : (i) to provide proof of ownership along with application and (ii) NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.

- Premises preferably be located on ground floor. There could be a few exceptions like premises in Malls, shopping center etc, where infrastructure like lifts, escalators are available.

- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, Safe & Lockers Cabinet. **Construction for Strong Room as per Reserve Bank of India guideline as well as Bank's specification should be done by the Landlord.**
